## NOTIFICATION FOR COUNSELLING FOR APPOINTMENT OF RESERVED CATEGORY CANDIDATES (PARA-TEACHERS, EXEMPTED CATEGORY, EX-SERVICEMAN & PH)

In continuation of our notification under memo no. 330/BPE/2021, dtd 15.02.2021 this is to notify that district wise approved panels for appointment of candidates against earmarked category vacancies (Para Teacher, Exempted Category, Ex-Serviceman & PH) of their respective mediums and categories are hereby published in order of their respective merits.

Apart from the above, it is also to notify that a state level counselling will be held for the merit listed earmarked category candidates who could not be empanelled in their own districts because of non-availability of vacancies according to their mediums and categories in terms of their merit.

Again, it is notified that all candidates against earmarked vacancies stated above of Alipurduar and Jalpaiguri, Paschim Bardhaman and Purba Bardhaman, Jhargram and Paschim Medinipur have been merit listed according to their TET-2014 Roll Numbers. The first 2 (two) digits of such Roll Numbers are the district codes as they were at the time of holding TET-2014.

The aforementioned districts - Jalpaiguri, Bardhaman, Paschim Medinipur were then undivided. The Board has empanelled all the eligible candidates in accordance with the codes of the undivided districts.

Now, the Department of School Education has forwarded the vacancy statements of such districts separately. Therefore, it is decided that both the authorities of the District Primary School Councils of Alipurduar and Jalpaiguri, Paschim Bardhaman and Purba Bardhaman, Jhargram and Paschim Medinipur will hold jointly the counselling of all the earmarked candidates empanelled for those three undivided districts to allocate the candidates for appointment in their respective home districts in order of merit. However, if any candidate remains un-absorbed will be allocated for appointment in either of the two districts (after division) as per available vacancies (medium and category wise).

Such counselling will be conducted at Purba Bardhaman, Jalpaiguri and Paschim Medinipur District Primary School Councils as per the following schedule.

It is also to be noted that all such empanelled candidates will have to carry their Aadhaar Cards / Voter ID Cards issued by the competent Govt. authorities.

All such candidates remaining 'Withheld' shall be cleared as per rules by the Board.

The merit listed candidates included in his/her medium and category marked as 'FOR COUNSELLING' will attend state level counselling (to be notified in due course) for empanelment and appointment in the District Primary School Council / Primary School Council where such vacancy of his/her medium-wise and category-wise would be available. No candidate marked as 'FOR COUNSELLING' would be empanelled or appointed by any District Primary School Council / Primary School Council before state level counselling.
